

## INSTRUCTIONS

### PRODUCTS WHICH REQUIRE REGISTRATION

Under Vermont Law all pesticides are denied as “Economic Poisons” and require state registration. An “Economic Poison” is defined as:

any substance produced, distributed or used for preventing, destroying or repelling any insects, rodents, nematodes, fungi, weeds, or other forms of plant or animal life or viruses, except viruses on or in living humans or other animals, which the Commissioner shall declare to be a pest or any substance produced, distributed or used as a plant regulator, defoliant or desiccant.

Pesticide products are misbranded if they do not display an EPA Registration Number or a Vermont Registration Number. Pesticide products which are 25(b) federally exempt may apply for a Vermont Registration Number by writing or calling:

### APPLICATION FOR REGISTRATION:

Submit the entire Application. Your Certificate of Registration will be mailed to you. Please type or print all information.

Attach securely to the application in order of products listed:

1. A copy of the federally registered label (actual product label not EPA approved label),  
OR
2. Labeling as required by the State of Vermont for registration of 25(b) federally exempt products, including a copy or statement of all claims that will be made for this product,  
**AND**
3. A Material Safety Data Sheet for **ALL** products registered.

**Please staple together the label and the Material Safety Data Sheet in sequence as listed in the application.**

**PRODUCT NAME(S):** List these on the Application under the headings and in the order—“Renewals,” “New Registration,” and “Discontinued.” (“Renewals” are reregistrations from the previous year; “New Registrations” are products not registered the previous year; and “Discontinued” are products which were registered the previous year and are no longer being marketed in Vermont.) All pesticide products, whether classed as New, Renewal, or Discontinued, require a registration fee. However, Discontinued products must be registered two years after distribution is declared discontinued.

If the products of a subsidiary which do not bear the name and address of the registrant are to be included on the same application with the registrant’s products, add the name and address of the subsidiary to the application, grouping its products thereunder.
